ACTION ITEMS

Approval of Resolution of Intergovernmental Relationship

WHEREAS, the City of Clawson and the Clawson Public Schools recognize the importance of a harmonious and collaborative relationship between the administrations of the school district and city; and

WHEREAS, our appointed executive leaders have diligently collaborated and believe there is immense community value and a priority to intentionally join forces to collaborate and ensure we move the Clawson community to "Grow Forward Together;" and

WHEREAS, this understanding that our school district cannot meet its greatest potential without a strong city and our city cannot reach its ultimate potential without strong schools. This proclamation hereby memorializes the intent, understanding and mutual efforts between our governing bodies and directs the Clawson Public School's

administration and the City of Clawson's administration to collaborate on any and all aspects of the school district and the city for the betterment of its students and residents; and

WHEREAS, first and foremost is the safety of our community especially our children followed by optimizing each tax dollar to its fullest extent; and

WHEREAS, the most immediate and community wide impacting opportunity for our collaboration is the current and ongoing right sizing of school district facilities; and

WHEREAS, this necessary effort has generated concerns for community stakeholders in regard to potential loss of sports fields, assets and programing. However, both elected bodies and administrations recognize this an opportunity for greater intergovernmental cooperation coupled with increased sincere community outreach; and

WHEREAS, this is an exceptionally sensitive and far-reaching topic. There is a need to coalesce our resources and community stakeholders around the examination of optimizing our buildings sites, athletic assets, recreation assets/services, parks and senior services; and

WHEREAS, the district and city have the same taxpayers; we shall continually demonstrate to them the best use of all assets and services for their increased benefit; and

WHEREAS, we also need our community stakeholders' experience, opinion, expertise and energy; and

WHEREAS, in order to achieve communal optimization of our assets and programing the district and city agree to form a Joint Task Force. A Task Force can be defined as a group established to work on a defined task or activity. The addition of the word "Joint" is to bring significance to our intergovernmental and communal approach; and

WHEREAS, The Joint Task Force thus far was loosely comprised of key staff from both administrations, and will now evolve into the inclusion of one to two elected members from each governmental body and ultimately the inclusion of members from various identifiable community stakeholder groups; and

WHEREAS, This Joint Task Force will be charged with seeking, developing and vetting suggestions for the optimization of buildings sites, athletic assets, recreation assets/services, parks and senior services for the collective benefit of the Clawson Community.

NOW, THEREFORE BE IT RESOLVED, that by virtue of our collective authority vested in us by the community of Clawson, we renew our intergovernmental relationship with open minds, with commitment to communication until consensus is reached and with a willingness to consider all options. Only through transparency and our willingness to work together we will retain the confidence of our residents with the goal of making our community stronger for all stakeholders.

Mr. Rheker, City Manager, will prepare a report regarding the options involving the school buildings and what is best for the community.

Mr. Shellenbarger stated that there will be a recommendation at the February 26, 2024 board meeting.
