#### A. BOARD CORRESPONDENCE:

Mrs. Gould read a thank you letter from Maurissa Rose-Smith for the board's support of National Recovery Month and National Suicide Prevention Month and for helping to bring awareness to these critical issues in our community.

c. Government Relations Committee: Mr. Frink reported that the OCSBA GRC committee met on October 11. We received a legislative update from Lisa Hansknecht, the Executive Director of Government Relations for Oakland Schools. SB 463 would require the completion for the FAFSA, federal student loans

application to receive a diploma. Currently this bill is being opposed by Oakland Schools. The Senate Education Committee is looking at 2 bills, SB 395 and SB 396 that would make changes to teacher and administrator evaluations. Currently Oakland Schools opposes these bills and they are tracking them to see if they move out of committee. House Higher Education Committee is reviewing HB 4816 which would allow High School Athletes to receive compensation for the use of their name, image or likeness. It is similar to changes made for college athletics. The House Labor Committee is reviewing HB 4932 which would limit youth employment between Midnight and 5 AM and also from performing hazardous or injurious jobs. The next meeting is scheduled for November 1.

d. <u>Facility Committee</u>: Mr. Verner reported that the committee met virtually on October 11. There was a bond update. There was also discussion regarding change orders, the sale of Baker and Schalm, an update on walkie-talkies, district fobs, and an update on the baseball/softball field.

# C. <u>Approval of New Elementary and Supplemental Security Camera Additions and Approval of Purchase</u>

WHEREAS, this purchase is being made with previously allocated bond dollars, based off of pricing in a bid that was awarded to CBTS for Lapeer Community Schools; and

WHEREAS, there were 8 bids submitted, and after a full bid analysis by the Oakland Schools Security team, the bid was awarded to CBTS; and

WHEREAS, as part of that RFP, CBTS has agreed to offer the reciprocal pricing to all districts in Lapeer and Oakland County.

NOW THEREFORE, BE IT RESOLVED that the Clawson Board of Education authorizes the superintendent or his designee to finalize the purchase of Security Cameras from CBTS in the amount of \$29,794.74 for the High School and Baker as well as the amount of \$90,132.46 for the New Elementary, as presented.

There are two separate attached proposals that separate the new Elementary School Scope and the additional district needs scope. We are asking that the Board considers approving this proposal tonight so that this work can begin immediately.
