B. Oakland Schools County-Wide Enhancement Millage

We had significant conversation in our OCSA meeting Friday about the Oakland County Enhancement Millage. Our ISD is doing a significant amount of diligence to figure out whether or not to put it on the ballot next year. They did a survey and got results back that show "yes" at around 60% in preliminary polls that were conducted via phone. The county group is split related to Board support, and they want an answer from each district in our January meeting whether or not our boards support putting it on the ballot. If it goes on the ballot, that means we have to actively campaign for it from the Superintendent's perspective. It will be a 1.5 or 1.75 mill increase if passed. Both Macomb and Wayne Counties have passed theirs in recent years.

The board was in consensus that it was not a good time to support placing it on the ballot.
